Minutes of the meeting of Wednesday, February 5, 2025.

Redwood Collegiate Academy open for public comment.

### I. Welcome and Training

- A. The meeting was called to order at 2:08 p.m. by Leo Davis. Seven of eight Council members were in attendance:

- B. Adoption of Agenda

1. On a first by C. Cimmiyotti and a second by L. Keast, the Council voted (7-0) to adopt the agenda as written.

- A. On a first by C. McClure and a second by L. Keast, the Council voted (7-0) to approve the December 4, 2024 Minutes as written.

### III. Discussion and Reports

- A. The committee reviewed but proposed no official changes to the LCAP and Federal Addendum at this time.
- B. It was agreed that the four goals listed in the LCAP are still significant and relevant to the mission of Redwood Collegiate Academy. In particular, L. Davis voiced feeling optimistic about the school climate goal (Goal #3) and positive that pursuit of this objective should continue.
- C. C. McClure voiced concerns about the threat of artificial intelligence on education and earnestly recommended the development and adoption of schoolwide AI Policies to enhance and preserve student learning.
- D. It was mentioned that student planners continue to be underutilized by students.
- E. There was much discussion about Guided Study and its impact on preparing students for college. It was mentioned that Guided Study offers equitable access to computers and the Internet for all students. It was also suggested that higher level courses might prepare students for college better

by assigning work that encourages completion outside of Guided Study. It was also proposed that teachers revisit late work policies to help train students in adhering to timelines.

- F. C. Cimmiyotti posed the question “what are some strategies for keeping up enrollment at our school?” This led to discussions about the status of middle and high school enrollment in Northern California in general.
